Digital Document Execution

Digital Document Execution (DDE) Platform is a Web API based platform/service forDemat of Loan documents.

NeSL-IU provides a Digital Platform for execution of loan contracts. The Loans Appraisal and Processing System of the Bank will be integrated with the DDE Module of NeSL, which will be used by calling the form-based API published by NeSL.

DDE API Form Based Request

Below are the five parameters that need to be passed as part of the https form-based webAPI request as a POST call:
