GUJARAT STAMP ACT, 1958.

NO.GHM-2021-131-M-STP-122020-1751-H-1:- In exercise of the powers conferred by sub-clause (iv) of clause (k) of section 2 and section 10 of the Gujarat Stamp Act, 1958, (Born. Lx of 1958) read with the Gujarat Stamp (Payment of Duty by Means of E-Stamping) Rules, 2014, the Government of Gujarat hereby authorises the Central Record Keeping Agency (CRA) i.e. Stock Holding Corporation of India Limited (SHCIL) to implement digital E-Stamping of the documents executed in electronic form on the web portal of National E-Governance Services Limited (NeSL) for the following non-registerable instruments enumerated in the Schedule-1 of the Gujarat Stamp Act, 1958, namely:-
