1.15 **DELAY PENALTY:**

1.15.1 **The Successful Bidder shall dismantle and remove all the assets of the Phase-II Power Plant with its Building Structures as referred to in the sale notice dated 01.03.2025 within a period of 15 (Fifteen) months from the date of LOI, failing which after 15<sup>th</sup> month and up to 17<sup>th</sup> month from the date of LOI the Successful Bidder shall be liable to pay “Delay Penalty” of Rs.1,00,00,000/- (Rupees One Crore only) on the accepted bid amount for default/delay of every month or proportionately for part thereof payable on or before seventh day of the succeeding month of such delay/default.**

1.15.2 **Further, if the assets (Phase-II power plant with its Building Structures) are not removed by the successful bidder within 6 (six) months i.e., where the dismantling is not completed within 21 (Twenty-One) months from the date of LOI the sale will be short closed on the expiry of the 21<sup>st</sup> month from the date of LOI. The Security Deposit paid will be forfeited.**

- 1.15.3 **The Successful Bidder will not be allowed to proceed further and the sale contract will be short closed. Such Successful Bidder will not be allowed remove any further material and the left-over assets available at the site will be re-auctioned or dismantled and removed at the risk and costs of Successful Bidder. Accordingly, the Sale Invoice will be issued only for the value of the material (as may be decided by the Liquidator) removed from the Plant Site prior to such Short Closure. The Liquidator shall have the right to dispose of the remaining P&M.**
- 1.16 The Bidders shall inform themselves concerning and shall observe and comply with, any applicable legal requirements. Foreign investors should comply with Foreign Exchange Management Act, 1999 and RBI regulations as may be applicable.
- 1.17 The laws of the Republic of India are applicable to this e-Auction Process Information Document.

## **2. KEY DEFINITIONS**

- 2.1 **“Adjudicating Authority” or “NCLT”** shall mean the National Company Law Tribunal, Hyderabad Bench
- 2.2 **“Affidavit and Undertaking”** shall mean the affidavit and undertaking provided by the Bidder substantially in form and manner as annexed in **Annexure I** here to.
- 2.3 **“Applicable Law(s)”** shall mean, any or all the applicable laws, codes, regulations, rules, guidelines, circulars, re-enactments, revisions, applications and adaptations thereto, judgments, decrees, injunctions, writs and orders of any court, arbitrator or governmental agency or authority, rules, regulations, orders and interpretations of any governmental authority, court or statutory or other body applicable for such transactions including but not limited to the IBC, Liquidation Process Regulations, Companies Act, 2013, Competition Act, 2002 , Income Tax Act, 1961, The Goods and Services Tax Act, 2017, Transfer of Property Act, 1882, Sale of Goods Act, 1930, Foreign Exchange Management Act, 1999, whether in effect as on the date of this e-Auction Process Information Document or thereafter and each as amended from time to time.
- 2.4 **“Assets”, Plant & Machinery and Power Plant Buildings**: All the plant & machinery comprising mainly of i) 148.85 MW Alstom (GT13E2 DUAL FUEL) Gas turbine; ii) 80MW Alstom (NE33AA triple pressure) steam turbine and iii) other equipment, electrical, fittings, inventory, stores, furniture & fixtures and Buildings of Phase II Gas based power plant having capacity of 220 MW situated at Jegurupadu, Rajamahendravaram, East Godavari Dt, Andhra Pradesh excluding land, advertised **under Sale Notice dated 01.03.2025**.
- 2.5 **“Associate Company”**, in relation to another company, means a company in which the Bidder has a significant influence in terms of the Companies Act of 2013, and includes an Affiliate of the Bidder having such influence and includes a joint venture company.

- 2.6 **“Bid”** means, any bid or offer along with other document, submitted by the Bidder(s) as required in terms of the Public Advertisement/Sale Notice and this e-Auction Process Information Document issued by the Liquidator and in accordance with the provisions of the IBC read together with the IBBI (Liquidation Process) Regulations, 2016 as amended from time to time and other Applicable Law(s);
- 2.7 **“Bidder(s)”** shall mean a Person or Persons as the case may be, who is interested in submitting a Bid as per the e-Auction Process Information Document and shall include a Prospective Bidder or the Successful Bidder, as the case may be, and as the context requires;
- 2.8 **“Bid Application Form”** shall mean the form as specified in **Annexure III** of this e-Auction Process Information document.
- 2.9 **“Bid Declaration Form/Declaration by Bidders”** shall mean a declaration by the Bidders in form as specified in **Annexure IV** of this e-Auction Process Information Document.
- 2.10 **“Company” or “Corporate Debtor” or “GVKIL”** shall mean **M/s. GVK Industries Limited, CIN: U74999TG1992PLC014388**, a company incorporated in India under the Companies Act of 1956, having its registered office at Plot # 10, Paigah Colony, Phase-I, Sardar Patel Road, Secunderabad, Hyderabad, Telangana-500,003 and in Liquidation under the provisions of Insolvency and Bankruptcy Code, 2016 pursuant to the order of the Hon'ble National Company Law Tribunal, **Hyderabad Bench dated 15<sup>th</sup> December 2022**.
- 2.11 **“Confidential Information”** shall mean any and all information and other materials disclosed, furnished, communicated or supplied by the Company to any bidder, in written or electronic or verbal form or through virtual data room and shall be determined to include (without limitation) the following types of information of a similar nature: any commercial and / or financial information, improvement, know-how, intellectual property, discoveries, ideas, concepts, papers, techniques, models, data, documentation, manuals, flow charts, research, process, procedures, functions and other information related to price lists and pricing policies and any other information which the Company identifies to be confidential at the time of disclosure to the relevant bidder, and shall include any information that is provided by the Liquidator or his representatives pursuant to the Liquidation process or through the Confidentiality Undertaking, but excludes any information already available in the public domain;
- 2.12 **“Confidentiality Undertaking”** shall mean an undertaking as specified in **Annexure VII** herewith.
- 2.13 **“Data Room”** shall mean the virtual data room maintained by the Liquidator, created and provided on request by the Prospective Bidders to access information in relation to the Company.

- 2.14 “**e-Auction Process**”/ “**e-Auction**” shall mean the electronic auction process for the sale of the assets of the Corporate Debtor conducted in accordance with the provisions of IBC 2016, Liquidation Process Regulations, Applicable Law(s) and this e- Auction Process Information Document by inviting Bids from eligible Bidders for consummating the sale of the assets of the Corporate Debtor on collectively or parcels or standalone basis;
- 2.15 “**e-Auction Process Information Document**” means this document including all the annexures, formats hereto, and Data Room information/documents, for the purposes of setting out the process for submission of a bid and selection of Successful Bidder in accordance with the provisions of the IBC and Liquidation Process Regulations and shall include all supplements, modifications, amendments, addendums, alterations or clarifications thereto issued in accordance with the terms hereof;
- 2.16 “**Eligibility Criteria**” shall mean the criteria as specified in Clauses 5 and 12 of this e-auction Process Information document.
- 2.17 “**Group Companies**” shall include a holding company, subsidiary, associate company (including a joint venture company), affiliate, and a subsidiary of a holding company to which a company is also a subsidiary.
- 2.18 “**Highest Bidder**” shall mean the bidder whose Bid is confirmed as the H1 Bid in the e-Auction, for the sale of Assets (i.e., **Plant & Machinery along with power plant buildings**).
- 2.19 “**IBC**” shall mean Insolvency and Bankruptcy Code, 2016 as amended from time to time.
- 2.20 “**LOI**” shall mean the letter of intent (**Appendix C**) that will be issued by the Liquidator to the Successful Bidder detailing the terms and conditions to complete the sale of the assets of the company including the terms of payment by the Successful Bidder
- 2.21 “**Liquidation Process Regulations**”/ “**Regulations**” means, the IBBI (Liquidation Process) Regulations, 2016 as amended from time to time.
- 2.22 “**Liquidator**” means **CA Sai Ramesh Kanuparthi (K S Ramesh)**, an Insolvency Professional registered with Insolvency and Bankruptcy Board of India (IBBI) having registration number; IBBI/IPA-001/IP-P00910/2017-2018/11510, (Authorization for Assignment Valid up to 31.12.2025) appointed by Hon’ble National Company Law Tribunal, Hyderabad Bench, vide its order dated **15<sup>th</sup> December 2022**.
- 2.23 “**Next Highest Bidder**” shall mean the bidder whose Bid is confirmed as the H2 Bid in the e-Auction, for the sale of Assets (i.e., **Plant & Machinery along with power plant buildings**).

- 2.24 **“Person”** shall mean a natural person, a partnership firm (general or limited), an association, an unincorporated association, a union, a corporation, a limited or unlimited liability company, a company limited by guarantee, a joint venture, a Hindu undivided family (whether or not registered), an estate, a trust, a limited liability partnership, a body corporate, bank or financial institution, any other legal entity, an individual or government, state or agency of a state or any other legal entity with legal personality or any other body, whether incorporated or not.
- 2.25 **“Public Advertisement”** or **“Advertisement”** or **“Sale Notice”** shall mean the announcement dated **01.03.2025** in newspaper(s) **Business Standard (All India English Edition), Nava Telangana (Telugu - Hyderabad Edition), Prajashakthi (Telugu – Rajamahendravaram, East Godavari District Edition)** and inviting an Expression of Interest from the Bidders, who shall submit their Bid to participate in the Liquidation process of the Company in accordance with the provisions of IBC and IBBI (Liquidation Process) Regulations, 2016.
- 2.26 **“Representatives”** shall include partners, directors, officers, employees, affiliates, agents, consultants, advisors or such other representatives of the relevant Person expressly authorized by such Person pursuant to corporate authorizations, powers of attorney, authority letter or contract.
- 2.27 **“Reserve Price”** shall mean the Minimum Price as mentioned in the published advertisement at which a bid will be accepted on the E-auction platform from a participating Prospective Bidder. Provided that the Liquidator reserves the right to modify the reserve price in subsequent E-auction rounds as per applicable provisions of the Liquidation Regulations.
- 2.28 **“Sale Consideration”** wherever referred to in this document refers to the accepted BID amount and Sale Consideration shall always mean to also include payment towards applicable taxes/ Duties in addition to the accepted BID amount.
- 2.29 **“Site”** shall mean, severally or jointly, a power plant site situated at Jegurupadu\* Rajamahendravaram (Previously known as Rajahmundry), East Godavari District, Andhra Pradesh comprising of immovable and moveable properties, office premises, buildings, plant and machinery, owned by the Company, for the purposes of conducting business.
- 2.30 **“Site Visit”** shall mean a physical/in-person visit to the Site.
- 2.31 **“Stakeholders Consultation Committee (SCC)”** means the consultation committee, comprising of all creditors of the Corporate Debtor, to advise the Liquidator for proceeding with Liquidation Process.

- 2.32 **“Successful Bidder”** means, the Highest Bidder or the Next Highest Bidder as the case may be, declared as Successful Bidder by the Liquidator in consultation with the SCC as per the provisions of this e-Auction Process Information Document, IBC and the Regulations.
- 2.33 **Capitalized** terms used herein but not defined otherwise shall have the meaning prescribed to them under the provisions of the IBC 2016, the Liquidation Process Regulations and Applicable Law(s) to such terms as the context may require.

### **3. INTRODUCTION:**

An application was filed before the Hon'ble National Company Law Tribunal, Hyderabad Bench, Court II (“NCLT”) by a Financial Creditor namely Jammu & Kashmir Bank Limited against M/s. GVK Industries Limited (“Corporate Debtor”) under Section 7 of the Insolvency and Bankruptcy Code, 2016 (“IBC”) read with Rule 4 of the Insolvency & Bankruptcy (Application to Adjudicating Authority) Rules, 2016 (“IBC Rules”) for initiating Corporate Insolvency Resolution Process (“CIR Process”) against the Corporate Debtor under the provisions of IBC. The matter was admitted by the Hon'ble NCLT vide its order dated 21<sup>st</sup> April 2022 (the said order was uploaded on website of Hon'ble NCLT on 25<sup>th</sup> April, 2022) in CP No. 320/7/HDB/2020. The Hon'ble NCLT appointed Mr. Mukesh Verma as Interim Resolution Professional (“IRP”), with directions to perform all functions contemplated under the IBC including conducting the CIR Process in respect of the Corporate Debtor. The Committee of Creditors, in its first meeting held on 24<sup>th</sup> May, 2022, approved the continuation of Interim Resolution Professional, as Resolution Professional (“RP”).

Since no Resolution Plan was received, the RP filed the necessary application with NCLT as per the decision of the CoC for liquidating GVKIL. The Hon'ble NCLT, Hyderabad Bench passed an order dated 15<sup>th</sup> December 2022 and further extension orders dated 13<sup>th</sup> December 2023 and 11<sup>th</sup> June 2024 for Liquidation of the Corporate Debtor and appointed CA. Sai Ramesh Kanuparthi as the Liquidator to carry out the Liquidation of the CD in terms of the applicable provisions of IBC and Regulations and the directions of the Adjudicating Authority.

### **4. AN OVERVIEW OF THE COMPANY:**

M/s. GVK Industries Limited (“the Company or Corporate Debtor or CD”) is an unlisted public company, incorporated in the year 1992 with the Registrar of Companies Hyderabad, Andhra Pradesh. The main object of the Corporate Debtor was to set up and operate gas-based power projects. Accordingly, Corporate Debtor has been engaged in the business of Generation and sale of electricity.

In the year 1992, the Government of India (GoI) and the erstwhile Government of Andhra Pradesh (“GoAP”) contemplated setting up a 400 MW Combined Cycle Gas based Power Plant at Jegurupadu, East Godavari District, Andhra Pradesh as a substantial volume of gas was expected to be available from KG BASIN being developed by ONGC. GoAP selected GVK Industries Limited (“GVKIL”) to establish the said power station in two stages.

The Corporate Debtor commissioned Phase-1 of the project with a gross capacity of 216 MW on 20.06.1997 and continued to sell the entire electricity to the DISCOMS under the Power Purchase Agreement (“PPA”) dated 17.06.1993, subsequently amended on 19-04-1996. The Corporate Debtor sold the entire Phase -1 along with the entire land and common utilities developed for Phase II to DISCOM vide Agreement dated 08.02.2016 for a consideration of Rs 333.32 Crore. However, total consideration has not been received from APDISCOM.

The Corporate Debtor constructed Phase -II of the gas-based power project with a gross capacity of 220 MW, within the premises of Phase I. Phase II of the project commenced commercial operations on 14.4.2009. The project continued to sell entire electricity to the DISCOMS under the Power Purchase Agreement (“PPA”) dated 18.06.2003 till February 2013 and for a brief period during 2015 & 2016 when RLNG was made available under PSDF Support Scheme. Thereafter, the plant could not operate due to the non-availability of natural gas and alternative fuel i.e., HSD becoming unviable.

Brief particulars of the Corporate Debtor (GVKIL) are detailed in **Appendix A**.

## **5. PERMISSION TO ELIGIBLE BIDDERS TO PARTICIPATE IN THE e-AUCTION:**

- 5.1 The Bidders are required to submit the EMD of Rs.5.4 Crores along with EOI and all relevant Bid Documents.
- 5.2 **Minimum net worth requirement:**
- 5.2.1 At the individual level in case of individuals and a sole proprietorship, at the partnership’s level in case of a partnership, and at the body corporate’s level in case of body corporates, the minimum net worth shall be **Rs.10,00,00,000/- (Rupees Ten Crores only)** as per the Audited Financial Statements of immediately preceding financial year i.e., FY2023-24 and in its absence, latest available audited financial statement during 12 months preceding date of submission of EOI.
- 5.2.2 **For Financial Institutions / PE Funds / Asset Reconstruction Companies / NBFCs / Other Financial Investors**, the Assets Under Management (AUM) shall be a minimum of **Rs.100,00,00,000/- (Rupees One Hundred Crores only)** as per the Audited Financial Statements of the immediately preceding the completed financial year i.e., FY 2023-24, and in its absence the latest available audited financial statements during 12 months preceding the date of the EOI;
- 5.2.3 In case the consortium is of body corporates or partnerships or proprietorships or individuals, the minimum weighted average net worth shall be **Rs.20,00,00,000/- (Rupees Twenty Crores only)** at the consortium level. The consortium’s minimum weighted average net worth will be calculated for the relevant members at the individual level in case of individuals, at the partnership level in case of partnerships, at the proprietorship level in case of proprietorship, and at the body corporate level in case of body corporates in the immediately preceding completed financial year as per the Audited Financial Statements of immediately preceding completed financial year i.e. FY 2023-24 and in its absence, latest available audited financial statement during 12 months preceding date of submission of EOI.

- 5.2.4 **The** net worth certificate should be certified by a practicing Chartered Accountant.
- 5.2.5 **Net worth for Body Corporates means the** aggregate value of paid-up share capital and all reserves created out of the profits and securities premium account and debit or credit balance of profit and loss account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet but does not include reserves created out of revaluation of assets, write back of depreciation and amalgamation.
- 5.2.6 **Net worth for Partnership firms / Individuals means** value of all tangible assets less all liabilities.
- 5.3 On the Prospective Bidder(s) being found eligible, based on verification of Documents submitted, such Bidder(s) will be Issued appropriate letter permitting participation in the e-Auction. The Liquidator has the sole right to decide on disallowing any / all bidder(s) to participate in the e-Auction without mentioning any reason what so ever.
- 5.4 Applicants can refer to the website of the service provider <https://nesl.co.in/auction-notices-under-ibc/> for further details or any amendments thereof. Notwithstanding anything mentioned above, the Liquidator reserves the right to decide whether the bidder is eligible or not.

## **6. DOCUMENTS REQUIRED TO BE SUBMITTED TO ASCERTAIN ELIGIBILITY OF THE BIDDER:**

- 6.1 The Bidder would need to submit required forms, documents, and authorizations as part of the e-Auction as per the timelines prescribed in this e-Auction Process Information Document.
- 6.2 Ownership structure and composition of the Bidder, Proof of Identification, Current Address Proof, PAN card, Aadhar Card, valid e-mail ID, landline and mobile phone number, KYC details of connected persons as defined in Sec 29A of IBC.
- 6.3 Certified copies of Certificate of Incorporation, MOA, AOA, partnership deed, Latest audited financial statements, Latest Income Tax Returns, CIBIL Reports, etc. of the applicant/bidder, PAN and Aadhar, latest CIBIL Report of all Directors / partners and PAN and Aadhar of all connected persons as per Sec 29A of IBC, Latest Income Tax Returns of all Directors for last 3 financial years.
- 6.4 Authorization to the Signatory (in **Annexure-V** case the bidder is a legal entity/consortium).

- 6.5 The interested bidder must submit the Affidavit and Undertaking and Confidentiality Undertaking (through an Authorized Signatory in case the bidder is a legal entity). The format for the Affidavit and Undertaking is attached as **Annexure I** and the format for the Confidentiality Undertaking is attached as **Annexure VII** and the format for undertaking for removal of plant & Machinery is attached as **Annexure-VIII**.
- 6.6 A Bidder will need to submit EOI in **Annexure-II** and duly filled, stamped and signed Bid Application Form attached as **Annexure III**, and duly filled, stamped and signed Bid Declaration Form/Declaration by Bidders attached as **Annexure IV**.
- 6.7 Further, it should be noted that at any stage of the E-Auction Process, the Liquidator may ask for further documents from the Bidder(s) to evaluate their eligibility. The Liquidator, at his discretion, may disqualify the Bidder(s) for non-submission of the requested documents.

## **7. SITE VISIT:**

- 7.1. Any interested Bidder/ Prospective bidder will be allowed to visit the site on any date as may be mutually agreed upon, with the prior permission of the Liquidator. Such bidder / Prospective Bidder is expected to make its own arrangements including accommodation etc. All costs and expenses incurred in relation to Site Visits shall be borne by the Bidder alone.
- 7.2. The Bidder/Prospective Bidder(s) may carry out its own comprehensive Due Diligence in respect of the assets of GVKIL and shall be deemed to have full knowledge of the condition of the Company, its assets, relevant documents, information etc. whether or not the Prospective Bidder actually inspects or participates in the Site Visit or verifies the document provided by the Liquidator. During the Site Visit, a bidder/Prospective Bidder shall not:
- (i) take any documents back with it; or
  - (ii) Initiate any discussion regarding the Liquidation Process with the personnel at site.
- 7.3. The bidder/Prospective Bidder(s) shall not be entitled to receive any reimbursement of any expenses which may have been incurred in carrying out of due diligence, search of title/ownership to the assets and matters incidental thereto or for any purpose in connection with the Bid.
- 7.4. Any delay in completion of the Site Visit by the bidder/Prospective Bidder(s), shall not entitle them to any extension in the timelines, including a timeline for submission of the Bid on or before the last date for submission of the Bid.

## **8. DUE DILIGENCE/DATA ROOM/CLARIFICATIONS:**

- 8.1. Access to Virtual Data Room (VDR) shall be provided to all the Prospective Bidders along with access to all relevant documents relating to assets of the Corporate Debtor put for sale. The Liquidator shall endeavor to provide necessary assistance, facilitating the due diligence by Prospective Bidders. The information and documents shall be provided by the Liquidator in good faith.
- 8.2. The Liquidator proposes the sale of the assets of the Corporate Debtor M/s. GVK Industries Limited (In Liquidation) collectively or in parcels, whichever is applicable under Reg 32 (a) to (d) of Liquidation Process Regulations on “***As is where is basis***”, “***As is what is basis***”, “***Whatever there is basis***” and “***No recourse basis***” and the proposed sale as specified above does not entail the transfer of any title/ownership, except the title/ownership which the Company has on the assets as on date of the transfer. All local taxes/maintenance fee/electricity / water charges / annual lease rentals / unearned income in case of leasehold assets, etc., outstanding as on date or yet to fall due in respect of the relevant assets of the CD should be ascertained by the Bidder and would be borne by the Successful Bidder. It must also be noted that the Liquidator does not give any assurance or warranty of the physical condition of the assets and their suitability for any sort of operation that the bidder envisages.
- 8.3. The Bidders should make their own independent inquiries regarding the encumbrances, titles of Assets and claims/rights/dues/affecting the Assets and should conduct their own due diligence prior to submitting their Bid. The Process Document does not constitute any representation or offer by the Liquidator. Sale of the assets of the Corporate Debtor on a ‘collective basis’ and/or ‘parcels’ under Regulation 32(a) to (d) of the Liquidation Process Regulations is being done with all the existing and future encumbrances/ claims/dues /demands whether known or unknown to the Liquidator. The Liquidator shall not be responsible in any way for any third-party claims/rights/dues.
- 8.4. **CLARIFICATIONS:**
- 8.4.1. While the data/ information provided in this e-Auction Process Information Document and the Data Room, has been prepared and provided in good faith, the Liquidator and his representatives shall not accept any responsibility or liability, whatsoever, in respect of any statements, error or omissions herein, or the accuracy, correctness, completeness or reliability of the information provided, and shall incur no liability under any law, statute, rules or regulations as to the accuracy, reliability and completeness of the information provided, even if any loss or damage is caused to any of the Bidder by any act or omission on their part.
- 8.4.2. It is further clarified that the data/information provided in the Data Room has been prepared based on books of account, financial statements, the Company’s website, discussions, and representations furnished by the erstwhile directors and key managerial personnel of the Company. Reasonable care has been taken in compiling various data and information. However, the Liquidator along with his, consultants, or representatives, makes no representation or warranties, express or implied, as to the quality, accuracy,

authenticity, correctness, fairness, and completeness of the data provided in the Data Room, and assumes no liability whatsoever in respect of any inaccuracy, incompleteness, or omissions in the data provided in the Data Room

- 8.4.3. Any clarification uploaded in the Data Room shall be binding on all the Bidders and shall be deemed to form part of this e-Auction Process Information Document. No request for modifications of the clarifications shall be entertained, however, the Liquidator, may, in a fit case and as per his discretion, issue modification to the clarifications, if required. Such modifications(s) shall be binding on all the Bidders and shall be deemed to modify the clarification and be read as a part of this e-Auction Process Information Document.
- 8.4.4. Bidders requiring any clarification on this e-Auction Process Information Document, Liquidation Process, submission of the Bid or on the Company shall email such request for clarification to email: [info@ksrfms.com](mailto:info@ksrfms.com) / [liqgvk@gmail.com](mailto:liqgvk@gmail.com)
- 8.4.5. The Liquidator reserves the right not to respond to any query or provide any clarification, at his sole discretion, and no extension of time and date referred to in this e-Auction Process Information Document shall be granted on the basis of not having received a response to clarifications sought from the Liquidator.
- 8.4.6. Nothing in this Clause shall be considered or read as compelling or requiring the Liquidator to respond to any query or to provide any clarification to the queries raised by a bidder. The Liquidator will not be held responsible for any delay in response or non-response to clarifications raised by the Bidder.

## **9. ASSETS TO BE AUCTIONED, MODE OF SALE AND RESERVE PRICE:**

- 9.2. The Liquidator is conducting the sale of the asset of the Corporate Debtor as allowed under Regulation 32 (a) to (d) of the Liquidation Process Regulations read with Schedule I of the said Regulations and other applicable provisions of IBC 2016.
- 9.3. After identification of a Successful Bidder, the Liquidator shall have the right to approach the Hon'ble NCLT to obtain suitable directions on the implementation of such sale, and any such directions shall be binding on the parties to the sale process as contemplated in this e-Auction Process Information Document and where such the sale certificate will be issued subject to the approval of NCLT.

10.2.4 The Stakeholders Consultations Committee ("SCC") of GVK Industries Limited in its meeting held on 01.01.2025 has approved for payment of the balance **Sale Consideration** (i.e., accepted Bid amount plus other applicable taxes/duties after set-off/adjustment of EMD received) within 120 days from the date of issuance of LOI as per the provisions of Reg. 31A (1)(h) of the IBBI (Liquidation Process) Regulations, 2016.

- 12.7 The Successful Bidder agrees that it shall be bound to pay the Sale Consideration (net of the Earnest Money Deposit already paid) as mentioned in **the Letter of Intent (LOI)** that shall be issued by the Liquidator for completion of sale. - 13.1 Provided further that, the sale shall stand canceled if the payment of balance Sale Consideration ( I.e., accepted Bid amount plus other applicable duties / taxes after set-off / adjustment of EMD received) apart from interest @12% p.a. as may be applicable as per Schedule-1 Clause 1 (12) of Liquidation Process Regulations is not received within the above stipulated 120 (One Hundred and Twenty) days from the date of LOI. **Consequently, the EMD and all monies paid by the successful bidder shall stand forfeited.**
- 13.1 Upon receipt of the full amount of Sale Consideration ( I.e., accepted Bid amount plus other applicable duties / taxes after set-off / adjustment of EMD received) from the Successful Bidder within a maximum period of (one hundred and twenty ) 120 days from the date of LOI (along with interest as applicable), a certificate of sale / Sale invoice as the case may be issued by the Liquidator to the Successful bidder which is however subject to the satisfaction of Removal Terms referred clause 14.
- 13.1 Simultaneously, the Successful Bidder shall have the option of deploying additional security personnel, as may be mutually agreed, at its sole cost and expenses, in the premises of the power plant. Provided that, in the event the Liquidator requires the removal of any person from the security team, the Successful Bidder shall be obligated to replace such personnel without any undue delay. The right to appoint such security personnel shall stand terminated immediately in the event the Successful Bidder fails to pay the balance sale consideration ( I.e., accepted Bid amount plus other applicable duties / taxes after set-off / adjustment of EMD received) along with additional Security Deposit within the specified term. The security personnel so deployed shall function only under the directions of the Liquidator and shall not have any rights to allow or prevent any ingress or egress of persons or material from the site without the specific approval of the Liquidator.

#### **14. REMOVAL TERMS & OTHER CONDITIONS:**

- 14.1 On payment of the full amount of Sale Consideration ( I.e., accepted Bid amount plus other applicable duties / taxes after set-off / adjustment of EMD received) by the Successful Bidder along with the interest as applicable, the sale shall stand completed, and the Liquidator shall execute Certificate of Sale and/or Invoice as the case may be and shall handover / transfer the ownership of the assets of the Corporate Debtor to the Successful Bidder of the asset on "*as is where is*", "*as is what is*", "*whatever there is*" and "*no recourse*" basis. - 14.4 Further, if the assets (Phase-II power plant with its Building Structures) are not removed by the Successful Bidder within 6 (six) months i.e., where the dismantling is not completed within 21 (Twenty-One) months from the date of LOI the sale will be short closed on the expiry of the 21<sup>st</sup> month from the date of LOI. The Security Deposit paid will be forfeited
- 14.5 The Successful Bidder will not be allowed to proceed further and the sale contract will be short closed. Such Successful Bidder will not be allowed to remove any further material and the left-over assets available at the site will be re-auctioned or dismantled and removed at the risk and costs of Successful Bidder. Notwithstanding anything to the contrary contained in this e-Auction Process Information Document, the Liquidator shall reject the Bid, without being liable in any manner whatsoever to the Bidder, if the Liquidator, at his discretion, determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the E-Auction Process or has undertaken any action in respect of such process which results in the breach of any Applicable Law including the Prevention of Corruption Act, 1988. In such an event, the Liquidator may retain the EMD and all other sums/guarantees received till then, without prejudice to any other right or remedy that may be available to the Liquidator under this e-Auction Process Information Document or Applicable Law(s).

15.2 For the purposes of this Clause, the following terms shall have the meaning hereinafter respectively assigned to them:

**“Coercive practice”** shall mean impairing or harming, or threatening to impair or harm, directly or indirectly, any person or property to influence any person’s participation or action in the E-Auction Process.

**“Corrupt practice”** shall mean the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the actions of any person connected with the E-Auction Process. For avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of the Liquidator, who is or has been associated or dealt in any manner, directly or indirectly with the E-Auction Process or arising there from, before or after the execution thereof, at any time prior to the expiry of 1 (one) year from the date such official resigns or retires from or otherwise ceases to be in the service of the Liquidator, shall be deemed to constitute “corrupt practice”.

**“Fraudulent practice”** shall mean a misrepresentation or omission of facts or suppression of facts or disclosure of incomplete facts, in order to influence the E-Auction Process.

**“Restrictive practice”** shall mean forming a cartel or arriving at any understanding or arrangement among the Bidders with the objective of restricting or manipulating a full and fair competition in the E-Auction Process; and

**“Undesirable practice”** shall mean establishing contact with any person connected with or employed or engaged by the Liquidator with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the E-Auction Process; or (ii) having a conflict of interest.

15.3 The Bidder shall not involve himself or any of his Representatives in price manipulation of any kind directly or indirectly under the Applicable Law(s) by communicating with other Bidders.

15.4 The Bidder shall not divulge either his Bid or any other details provided to him by the Liquidator or obtained during the due diligence process in respect of the Company to any other party.

## **16. COSTS, EXPENSES AND TAX IMPLICATIONS:**

16.1 The Bidder shall be responsible for all costs incurred by it on account of its participation in the E-Auction Process, including any costs associated with participation in the discussion meeting(s) (if any), Site Visit, etc. The Liquidator shall not be responsible in any way for such costs, regardless of the conduct or outcome of the E-Auction Process.

- 16.2 It is hereby clarified that the Bidder shall make its own arrangements including accommodation for the discussion meeting(s) (if organized) or Site Visit and all costs and expenses incurred in that connection shall be borne by the Bidder.
- 16.3 The Bidder shall not be entitled to receive any reimbursement of any expenses which may have been incurred while carrying out the due diligence, search of title to the assets of the Company and matters incidental thereto or for any purpose in connection with the E-Auction Process.
- 16.4 It is to be noted that all taxes (State & Central) or duties applicable to the sale transaction, whether Direct or Indirect, including applicable stamp duty and registration charges) on sale of the assets of the Corporate Debtor either 'collectively' or 'parcels', whichever applicable, under regulation 32 (a) to (d) would be borne by the Successful Bidder.
- 16.5 The Bidder shall be responsible for fully satisfying the requirements of the IBC and the related Regulations as well as all Applicable Law(s) that are relevant for the sale of the assets of the Corporate Debtor of the Corporate Debtor as contemplated under this auction process document (I). The Successful Bidder shall be responsible for obtaining requisite regulatory or statutory or third-party approvals, no objections, permission or consents, if any, that are or may be required under Applicable Law(s) in respect of the sale of the assets of the Corporate Debtor as contemplated in e-Auction Process Information Document.

## **17. GOVERNING LAW AND JURISDICTION:**

This e-Auction Process Information Document, the E-Auction Process and the other document pursuant to the e-Auction Process Information Document shall be governed by the laws of India and any dispute arising out of or in relation to the e- Auction Process Information Document or the e-Auction Process shall be subject to the exclusive jurisdiction of the Adjudicating Authority at Hyderabad.

## **18. BIDS SUBJECT TO A "CHALLENGE" PROCESS**

- 18.1 Notwithstanding anything contained elsewhere in this "e-Auction Process Information Document, and at any time after declaration of the "successful bidder", but before issuance of "letter of intent", the Liquidator may inform the "successful bidder" that the Liquidator intends to conduct a "challenge" auction process ("Challenge Process") in the interest of maximization of value of assets of the Corporate Debtor subject to necessary approval of the NCLT if required.
- 18.2 Where the Liquidator declares the intention to conduct a challenge, he shall, in consultation with the SCC, publish a notice of sale to that effect and inform the successful bidder and other persons who have been declared as Prospective bidders in the e-auction process of the same.

18.3 For the purpose of the challenge process the “successful bidder” in the e-auction round shall be considered as “anchor bidder” who need not participate in the challenge process but shall have the right to match the highest bid received during the challenge round, and on so matching, shall be confirmed as the “successful auction purchaser”.

18.4 `Other details, including timelines, of the challenge process, will be made available along with the notice of the same.

## **19. SALE OF THE ASSETS SUBJECT TO APPROVAL OF HON. NCLT HYD:**

The sale of the asset (Plant & Machinery with power plant buildings) of the Corporate Debtor under Regulation 32 (a) to (d) of IBBI (Liquidation Process) Regulations, 2016 shall be subject to the approval of Hon. NCLT Hyderabad Bench, if required or sought for by the Liquidator / SCC.

### BRIEF PARTICULARS OF CORPORATE DEBTOR M/s. GVK INDUSTRIES LIMITED (IN LIQUIDATION) AND BROAD DETAILS OF ASSETS

#### **1. Present Status:**

**1.1** The NCLT, Hyderabad admitted a petition by Jammu & Kashmir Bank Limited under section 7 of the IBC, 2016 against the Company, M/s. GVK Industries Ltd (GVKIL) and appointed an IRP vide its order dated 21.04.2022 who later on was confirmed as Resolution Professional

**1.2** The Hon. NCLT ordered the CD to be liquidated and appointed CA Sai Ramesh Kanuparthi (K S Ramesh) as the Liquidator in terms of the IBC, vide its order dated 15.12.2022 (brief order uploaded/received on 20<sup>th</sup> December 2022, detailed order uploaded on 2<sup>nd</sup> January 2023 and Certified copy of detailed order received on 5<sup>th</sup> January 2023)

#### **2. Details of the Company:**

**2.1** M/s. GVK Industries Limited (“the Company or Corporate Debtor or CD”) is an unlisted public company, incorporated in the year 1992 with the Registrar of Companies Hyderabad, Andhra Pradesh. The main object of the Corporate Debtor was to set up and operate power projects. Accordingly, Corporate Debtor has been engaged in the business of the Generation and sale of electricity.

**2.2** The Corporate Debtor has already sold Phase -1 of the project to APDISCOM with entire land (including land on which Phase-II Plant & buildings are located) but sale deed is yet to be executed due to pending payment of the balance sale consideration and other dues recoverable from APDISCOM. ▽

**Phase -II of the gas-based power project** with buildings as per the broad details mentioned in Annexure A, located at Jegurupadu, Rajamahendravaram (Previously known as Rajamundry), East Godavari District, Andhra Pradesh, and having a gross capacity of 220 MW commenced commercial operations on 14.4.2009 is for sale as per the sale notice issued on **01.03.2025**. Order for turnkey supply, erection & commissioning of the plant was placed with Alstom. As per the records of the Corporate Debtor, the plant achieved more than 90% PLF during its operation. The Project continued to sell entire electricity to the DISCOMS under the Power Purchase Agreement (“PPA”) dated 17.06.1993 till February 2013 and for a brief period during 2015 & 2016 when RLNG was made available under the PSDF Support Scheme. Thereafter, the plant could not operate due to the non-availability of natural gas and alternative fuel i.e., HSD becoming unviable.

**Major issues of concern relating to Phase -II of the project:**

- 1 The Corporate Debtor did not construct common facilities for Phase II as the same were sufficient for both phases. However, the same has been transferred to APDISCOMS under sale Agreement dated 08.02.2016 and the Continuation Agreement dated 22-04-2016 and these common facilities are not for sale. These utilities are being maintained by APDISCOMS only.
- 2 **As** on date, the Corporate Debtor is in possession of phase -II project - Plant & machinery and building only situated on the land parcel forming part of transfer of Phase-I to APDISCOMS.
- 3 **Broad** details of the assets are given in **Annexure-A**
- 4 **The** bidders need to carry out their own business and legal due diligence.

5. We further agree that, if the assets (Phase-II power plant with its Building Structures) are not removed by us within 6 (six) months i.e., where the dismantling is not completed within 21 (Twenty-One) months from the date of LOI the sale will be short closed on the expiry of the 21<sup>st</sup> month from the date of LOI. The Security Deposit paid will be forfeited
